All vendors are under the charge of the Friends of Oak Island Parks Foundation and must follow all park rules and regulations.

- Vendor Sites are drive-in for easy unloading and loading.

- Vendor set-up time is from 6 am - 7am. No late arrivals allowed.

- Vendors must be set up and ready to begin sales by no later than 7am, and will be required to discontinue sales and begin cleanup at 10am.

- Vendors must comply with all laws, ordinances, and regulations of the United States, State of North Carolina, Brunswick County, and Town of Oak Island.

· No live animals may be bought or sold or given away at the market.

· No grills or open fire cooking allowed.

· Pricing of goods sold at the market is solely the responsibility of the individual vendor.

- **ALL unsold items, trash, equipment, etc must be removed from town property.**

- Spaces are approximately 10 ft x 15 ft and will be assigned by staff.

- All vendors are responsible for supplying their own tents, tables, chairs and for setup and cleanup of vending area. Vendor spaces will be limited.

Early registration is highly recommended; event day registration will not be guaranteed. Event will be held rain or shine.
